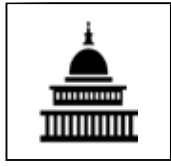

# WSPTA Awards FAQ

## HOW IS THE RECIPIENT CHOSEN?

A committee is appointed by the president to review recommendations.

## IS THERE A COST INVOLVED?

Yes — the donation of \$70, which includes the donation and price of the pin. Check the order form on the reverse side. This should be a budgeted expense.

## MAY ONE PERSON RECEIVE MORE THAN ONE GOLDEN ACORN AWARD/OUTSTANDING EDUCATOR AWARD/OUTSTANDING ADVOCATE AWARD?

This would depend on a unit or council's standing rules.

## MAY LOST PINS BE REORDERED?

Yes. A replacement pin may be ordered through the State PTA office. The cost for a replacement pin is \$22.00. An order form is available on the WSPTA website and in the Leadership Packet. This price includes sales tax.

## WHERE SHOULD I HAVE AWARDS MAILED?

When ordering awards, we request that you use your personal address for us to ship the award to your PTA. In the past, awards sent via the school are sometimes misplaced, which costs the PTA an additional time and money in reordering these awards.

### The Golden Acorn Award

is offered by the Washington State PTA for recognition of a volunteer who has given outstanding service to all children in the school community... not just an individual who has donated time to help in his/her child's class or a staff member who is doing a good job. It is to recognize volunteer service "above and beyond" a particular job description.

#### WHO CAN PRESENT ONE?

Local PTA units and councils

#### WHO MAY RECEIVE A GOLDEN ACORN?

Anyone may receive a Golden Acorn; however, this is a PTA award honoring volunteers who work for children and youth beyond the scope or responsibilities of a job.

#### WHY PRESENT A GOLDEN ACORN?

The benefit of presenting a Golden Acorn Award is two-fold. First, it recognizes an individual who has given outstanding service to children. Secondly, it supports scholarships for students pursuing post-secondary education. Donations are made in each recipient's name to the fund, which in turn contributes to the future of youth by awarding scholarships to students who are freshmen entering post secondary education.

#### INSTRUCTIONS FOR ORDERING GOLDEN ACORN AWARDS

#### WHO MAY RECEIVE AN OUTSTANDING EDUCATOR AWARD?

An outstanding educator could be a teacher, assistant, custodian, bus driver, administrator or community member.

#### WHY PRESENT AN OUTSTANDING EDUCATOR AWARD?

The enthusiasm and diversity that an educator brings to the classroom directly influences the success of a student. The benefit of presenting an Outstanding Educator Award is two-fold. First, this award enables PTAs to recognize innovative and successful individuals. Secondly, it supports scholarships for students pursuing post-secondary education. Donations are made in each recipient's name to the fund, which in turn contributes to the future of youth by awarding scholarships to students who are freshmen entering post secondary education.
