# **Pre-session Report** 2022 Legislative Session

## 2022 Session Starts under Virtual Protocols

Get your computers out, turn your light filters on, and update your virtual platform subscriptions. For the second year in a row, the Legislature will begin a formal regular session using protocols that allow only a few legislators to be on the House and Senate floor at a time and 100 percent virtual committee hearings and caucus meetings.

With the omicron variant spreading across the state, last week House and Senate Democrats adopted updated rules for the conduct of business. The goal, shared by legislative leadership, is to reassess frequently and adjust the limits when possible.

When the gavel falls at noon Monday, January 10, to start the 60-day session, here is a summary of the protocols:

- All committee meetings will be virtual. (This will not change.)
- The public is not allowed in the chamber corridors, offices, or galleries.
- In the Senate, floor action will be limited to 8 Democrats and 7 Republicans on the floor daily.
- In the House, floor action will be limited to 2 Democrats and 2 Republicans on the floor daily.
- Regarding COVID testing, legislators and staff will be required to test multiple times per week, and legislators who plan to be on the floor will have to test daily.

#### What to expect in 2022

This is the second year of the biennium, which means that the session is shorter, compressing the schedule significantly. (All bills that weren't enacted are eligible for action again this year, and more than 600 bills have been pre-filed and were introduced on Day 1!) Keep in mind that only about 10 percent of bills introduced make it across the finish line. We all will be breathing a huge sigh of relief at the first deadline for bills to pass out of policy committees on February 3, and from fiscal committees by February 7.

Rather than writing brand new budgets, legislators will adjust the operating, capital, and transportation budgets based on emergent needs and new priorities. With the rosy November 2021 revenue report forecasting nearly \$900 million in new and projected revenues for the current biennium (ends June 30, 2023) and another projected \$965 million for the 2023-25 biennium, not to mention \$1 billion in federal funding set aside last year, the state is fairly flush with cash. While that's a good place to be, it also has its own challenges – priorities vary among not just the two chambers but each of the caucuses.

Governor Jay Inslee submitted his proposed budgets mid-December. Lawmakers will take public testimony on those proposals the first week of session and then will turn their attention to drafting their proposals, which will be released late February following an updated revenue forecast.



As they always do, lawmakers gazed into the crystal ball with the Associated Press, this time on January 6. The first two hours of the taped segment are with representatives from the four legislative caucuses, and the last 45 minutes includes a discussion with Governor Jay Inslee. ## Advocacy in a virtual session

Regardless of what protocols might change regarding floor action or public meetings with legislators, all committee meetings will remain remote, allowing virtual participation three ways:

- Sign up to testify remotely, using the House or Senate committee sign-in portal;
- Submit written testimony which will be shared with committee members and become part of the official record on the bill; and
- State your position of Pro, Con, or Other with just a few clicks of a mouse.

Like last session, who testifies and how long will be allowed is up to the Committee Chair. The average is about two minutes, although individuals signed up to testify should plan a 90-second and a 60-second version just in case.

When an individual signs up to testify, a unique participation link will be generated and show on the page (this is new this year), and the link also will be sent to the email address provided on the sign up.

As in the past, all committee meetings will be televised by <u>TVW</u> and can be found on the day of, at or in the TVW archives.

A couple of other things to keep in mind:

- The portal for signing up to testify on a bill will close one hour prior to the start of the hearing.
- Submitting written testimony through the portal is allowed up to 24 hours after the public hearing.
