

## Legislative Principle Review Checklist – Amended Legislative Principles

Section A - General Criteria	Must be YES to all
1. Was the submission received by the deadline?	<ul style="list-style-type: none"> <li>• YES – Continue with review</li> <li>• NO – Stop review</li> </ul>

<p>5. Is the legislative principle consistent with PTA purposes, values, vision, and mission? To promote the welfare of children and youth in home, school, places of worship, and throughout the community;</li> <li>B. To raise the standards of home life;</li> <li>C. To advocate for laws that further the education, physical and mental health, welfare, and safety of children and youth;</li> <li>D. To promote the collaboration and engagement of families and educators in the education of children and youth;</li> <li>E. To engage the public in united efforts to secure the physical, mental, emotional, spiritual, and social well-being of all children and youth;</li> <li>F. To advocate for fiscal responsibility regarding public tax dollars in public education funding.</li> </ul>	<ul style="list-style-type: none"> <li>• YES – Continue with review</li> <li>• NO – Stop review</li> </ul>
6. Does this legislative principle meet the definition of a legislative principle?</p> <ul style="list-style-type: none"> <li>• Legislative principles are statements of conceptual legislative or public policy objectives that align with the association’s mission. These principles represent broad concepts and serve as the foundational basis for the legislative program.</li> </ul>	<ul style="list-style-type: none"> <li>• YES – Continue with review</li> <li>• NO – Stop review</li> </ul>

Does the legislative principle fit under an existing legislative principle category?</p> <ul style="list-style-type: none"> <li>• Budget, Revenue and Funding</li> <li>• Family and Community Engagement</li> <li>• Public Education Policies</li> <li>• Health and Well-Being of Children and Youth</li> <li>• Safe and Nurturing Environments for Children and Youth</li> </ul>	<ul style="list-style-type: none"> <li>• YES – Continue with review</li> <li>• NO – Stop review</li> </ul>

Section B - Legislative Principle Criteria	26 Points Max
<b>1. Legislative Principle Language Character Recommendation</b> Does it meet the recommendation of fewer than 100 characters, including spaces?	<ul style="list-style-type: none"> <li>• <b>3 points:</b> YES</li> <li>• <b>1 point:</b> 10 characters or less over the limit</li> <li>• <b>0 points:</b> More than 10 characters over the limit</li> </ul>
<b>2. Legislative Principle Topic</b> Does the topic warrant a legislative principle?	<ul style="list-style-type: none"> <li>• <b>5 points:</b> Topic warrants being a legislative principle</li> <li>• <b>3 points:</b> Topic may not warrant being a legislative principle and/or should be combined with an existing legislative principle</li> <li>• <b>0 points:</b> Topic does not warrant being a legislative principle and/or is overly specific</li> </ul>
<b>3. Legislative Principle Language</b> Is the topic and language broad enough to be appropriate for a legislative principle?	<ul style="list-style-type: none"> <li>• <b>5 points:</b> Language is broad enough to apply to legislative issues and resolutions</li> <li>• <b>3 points:</b> Language is slightly specific and may need to be broadened</li> <li>• <b>0 points:</b> Language is overly specific and should be broadened</li> </ul>
<b>4. Persuasive Statement Word Limit</b> Does it meet the limit of fewer than 250 words?	<ul style="list-style-type: none"> <li>• <b>3 points:</b> YES</li> <li>• <b>1 point:</b> 25 words or less over the limit</li> <li>• <b>0 points:</b> More than 25 words over the limit</li> </ul>
<b>5. Persuasive Statement Strength</b> Is it strong?	<ul style="list-style-type: none"> <li>• <b>5 points:</b> Accurately describes the problem being addressed, the proposed solutions, and makes a strong case for having the issue on the WSPTA platform</li> <li>• <b>3 points:</b> Needs some revision to better reflect the issue proposal and/or be more persuasive</li> <li>• <b>0 points:</b> Does not aid understanding of the issue and needs major revision</li> </ul>
<b>6. Citations</b> Is the submission information verified?	<ul style="list-style-type: none"> <li>• <b>5 points:</b> All information is verified</li> <li>• <b>3 points:</b> Most information verified; some is not verified</li> </ul>
<b>7. Stand-Alone or Combine</b> Should this legislative principle be combined with an existing legislative principle, another proposal, or other part of the platform?	<ul style="list-style-type: none"> <li>• YES</li> <li>• NO</li> </ul>
Section C – Submitter/Team Availability	4 Points Max
<b>8. Availability – Future Advocacy</b> Is the submitter/team willing and able to participate in advocacy for this principle, including taking part in weekly conference calls and testifying in Olympia?	<ul style="list-style-type: none"> <li>• <b>3 points:</b> Yes</li> <li>• <b>1 point:</b> Some involvement</li> <li>• <b>0 points:</b> No</li> </ul>
<b>9. Availability – Legislative Assembly</b> Will the submitter be available to attend legislative assembly?	<ul style="list-style-type: none"> <li>• <b>1 point:</b> Yes</li> <li>• <b>0 points:</b> No or unsure at this time</li> </ul>
