

## **Resolution Review Checklist – New Resolutions**

Section A - General Criteria	Must be YES to all
1. Was the submission received by the deadline?	<ul> <li>YES – Continue with review</li> <li>NO – Stop review</li> </ul>
2. Was the submission complete, including all required information and verifiable supporting evidence?	<ul><li>YES – Continue with review</li><li>NO – Stop review</li></ul>
3. Is the resolution statewide in scope?	<ul><li>YES – Continue with review</li><li>NO – Stop review</li></ul>
4. Does the resolution supplement but not conflict with the WSPTA legislative platform or with National PTA resolutions or position statements?	<ul> <li>YES – Continue with review</li> <li>NO – Stop review</li> </ul>
5. Is the resolution consistent with PTA purposes, values, vision, and mission? Does the resolution relate to the health, safety, well-being, and education of children and youth?	<ul> <li>YES – Continue with review</li> <li>NO – Stop review</li> </ul>

Does this resolution meet the definition of a resolution versus a legislative issue?</li> <li>Resolutions are long-term positions that offer solutions to policy issues at the federal, state or local school district level.</li> <li>Legislative issues are short-term positions that seek solutions that can only be accomplished through legislative action of the Washington state legislature.</li> </ul>	<ul> <li>YES – Continue with review</li> <li>NO – Stop review and refer to the resolutions committee</li> </ul>
8. Does the resolution fit under an existing resolution category?	YES – Continue with review

Section B - Resolution Criteria	37 Points Max
1. Title Character Recommendation Does it meet the recommendation of fewer than 60 characters, including spaces?	<ul> <li>3 points: YES</li> <li>1 point: 10 characters or less over the limit</li> <li>0 points: More than 10 characters over the limit</li> </ul>
2. Title Accuracy  Does it accurately describe the resolution?	<ul> <li>5 points: Title accurately describes the problem being addressed or the proposed solutions</li> <li>3 points: Title needs some revision to better reflect the problem being addressed or the proposed solutions</li> <li>0 points: Title does not aid understanding of the resolution and needs major revision</li> </ul>
3. Whereas Clause Limit  Does it meet the limit of 10 or fewer whereas clauses?	<ul><li>3 points: YES</li><li>-3 points: NO</li></ul>
4. Whereas Clause Strength  Whereas clauses should state why the action in the resolved clauses should be taken, should be broad in scope, use clear language with no undefined acronyms, and should all be addressed in a resolved clause.	<ul> <li>5 points: Whereas clauses are solid as proposed - need little revision</li> <li>3 points: Whereas clauses need some revision</li> <li>0 points: Whereas clauses need almost a complete rewrite</li> </ul>
5. Resolved Clause Limit  Does it meet the limit of 4 or fewer resolved clauses?	<ul><li>3 points: YES</li><li>-3 points: NO</li></ul>
6. Resolved Clause Strength Resolved clauses should be the strongest part of the resolution and should state what action or position should be taken to solve the problem set up in the whereas clauses. They should be actionable and strong and include a verb showing what action will follow in each resolved clause.	<ul> <li>5 points: Resolved clauses are solid as proposed - need little revision</li> <li>3 points: Resolved clauses need some revision</li> <li>0 points: Resolved clauses need almost a complete rewrite</li> </ul>
7. Persuasive Statement Word Limit  Does it meet the limit of fewer than 250 words?	<ul> <li>3 points: YES</li> <li>1 point: 25 words or less over the limit</li> <li>0 points: More than 25 words over the limit</li> </ul>
8. Persuasive Statement Strength Is it strong?	<ul> <li>5 points: Accurately describes the problem being addressed, the proposed solutions, and makes a strong case for having the resolution on the platform</li> <li>3 points: Needs some revision to better reflect the resolution proposal and/or be more persuasive</li> <li>0 points: Does not aid understanding of the resolution and needs major revision</li> </ul>
9. Citations Is the submission information verified?	<ul> <li>5 points: All information is verified</li> <li>3 points: Most information verified; some is not verified</li> </ul>
10. Stand-Alone or Combine Should this resolution be combined with another proposal or an existing part of the platform?	YES     NO

1. Purpose Alignment Is the resolution consistent with WSPTA's purposes, values, vision, and mission? Does it directly relate to the health, safety, well-being, and education of children and youth?  (See Section A5)	<ul> <li>5 points: Strong match to WSPTA purposes, values, vision, and mission. It directly relates to the health, safety, well-being, and education of children and youth</li> <li>3 points: Somewhat of a match to WSPTA purposes, values, vision, and mission. It somewhat relates to the health, safety, well-being, and education of children and youth. The match is not strong or may be outside the PTAs area of expertise</li> </ul>	
2. Opportunity for Multiple Levels of Advocacy  The topic can be advocated at multiple levels: family, school building, school district, city/county, and state.	<ul> <li>5 points: Topic is appropriate for multiple levels of advocacy</li> <li>1 point: Topic has limited opportunities for advocacy</li> </ul>	
3. Equity and Anti-Racism  Does the proposed resolution align with or support WSPTA's equity and anti-racism work?	<ul> <li>3 points: Strong alignment to equity and anti-racism work</li> <li>1 point: Moderate alignment to equity and anti-racism work</li> <li>0 points: No alignment to equity and anti-racism work</li> </ul>

If so, who?	<ul> <li>3 points: There are legislators and/or groups or coalitions currently working this topic, so there is a good chance for positive movement on the topic</li> <li>0 points: There are no known legislators and/or groups or coalitions currently working on this topic, so level of support for the topic is unknown</li> </ul>
